

TERMS AND CONDITIONS – CASIO G-SHOCK WITH SHELL PROMOTION

1. The Casio G-Shock with Shell (“Promotion”) will commence from 1 December 2017 until 29 December 2017; both core dates are inclusive (“Promotion Period”).
2. This Promotion is organized by Shell Malaysia Trading Sdn Bhd and is open to all citizens and permanent residents of Malaysia who are 18 years old and above and ONLY to whom are motorcyclists (“Customers”), except for the following category of persons who are NOT eligible to participate in the Promotion:
 - (a) permanent and/or contract employees of Shell, Affiliates of Shell, and their immediate family members (spouses, children, parents, brothers and sisters); and
 - (b) representatives, petrol station dealers, related service providers (including advertising agencies, promotion agencies, suppliers and event management agencies) of Shell, and/or Affiliates of Shell, their permanent and/or contract employees and their immediate family members (as defined above).
3. For the purposes of this Promotion, “Affiliate” means a company which directly, or indirectly through one or more intermediaries, controls, is controlled by, or is under common control with Shell. Relevant to this, “control” means the direct or indirect ownership of an aggregate fifty percent (50%) or more of voting capital.
4. This Promotion is ONLY available and limited to following Shell retail stations in Malaysia:
 - (a) Shell Station Taman Greenwood Park, Jalan Batu Caves; and
 - (b) Shell Federal Highway, Seksyen 1, Shah Alam (collectively, the “Shell Stations”).
5. Customers are entitled to participate in the Promotion upon the fulfillment of the following:
 - (a) Customers must first be a motorcyclist;
 - (b) Customers must complete the collection of stickers of either of the following combinations within the Promotion Period (“Promotion Pre-requisites”):

(i) COMBO 1: COLLECT FIVE (5) SHELL FUEL STICKERS AND FIVE (5) LUBRICANT STICKERS

Combo 1 – Shell Fuel Stickers

- In order to collect One (1) Shell Fuel sticker, Customer will need to purchase a minimum of Ringgit Malaysia Six (RM6.00) of either Shell V-Power 97 or Shell V-Power Racing (“Shell Fuels”) at the Shell Stations in a single receipt during the Promotion Period (“Promotion Shell Fuel Purchase”).
- As the requirement for Combo 1 is to collect Five (5) Shell Fuel stickers, the Promotion Shell Fuel Purchase must be carried out for Five (5) times.

- For the avoidance of doubt, Customer will only be entitled to redeem One (1) Fuel sticker for the Promotion Shell Fuel Purchase even if the Shell Fuels purchased is more than Ringgit Malaysia Six (RM6.00).

Combo 1 – Shell Lubricant Sticker

- In order to collect One (1) Shell Lubricant stickers for Combo 1, Customer will need to purchase a minimum of One (1) Shell Advance AX7 One (1) liter pack at the Shell Stations in a single receipt during the Promotion Period.

(ii) **COMBO EXPRESS: COLLECT ONE (1) SHELL FUEL STICKER AND ONE (1) LUBRICANT STICKER**

Combo Express – Shell Fuel Stickers

- In order to collect One (1) Shell Fuel sticker, Customer will need to purchase a minimum of Ringgit Malaysia Six (RM6.00) of either Shell V-Power 97 or Shell V-Power Racing (“**Shell Fuels**”) at the Shell Stations in a single receipt during the Promotion Period (“**Promotion Shell Fuel Purchase**”).
- As the requirement for Combo Express is to collect One (1) Shell Fuel sticker, the Promotion Shell Fuel Purchase must be carried out only once. To be entitled to one (1) Shell Fuel sticker, Customer will need to show proof of Shell Fuel purchase receipt.
- For the avoidance of doubt, Customer will only be entitled to redeem One (1) Fuel sticker for the Promotion Shell Fuel Purchase even if the Shell Fuels purchased is more than Ringgit Malaysia Six (RM6.00).

Combo Express – Shell Lubricant Sticker

- In order to collect Two (2) Shell Lubricant sticker for Combo Express, Customer will need to purchase a minimum of One (1) Shell Advance Ultra One (1) liter pack at the Shell Stations in a single receipt during the Promotion Period. To be entitled to one (1) Shell lubricant sticker, Customer will need to show proof of Shell lubricant purchase receipt.

(c) upon collection of the required Shell Fuels and Shell Lubricants Stickers (“**Promotion Stickers**”) for either Combo 1 or Combo Express, Customers must paste all the required Promotion Stickers onto the Shell-Casio Combo Card to be entitled to the Promotion Purchase (as defined in Clause 6 below). For the avoidance of doubt, the visual of the Shell-Casio Combo Card is set out below:



6. After completing the collection of the required Promotion Stickers for either Combo 1 or Combo Express, Customers are entitled to purchase either of the following Casio G-Shock watch models (“Promotion Purchase”) at the following price during the Promotion Period:
 - (a) Casio G-Shock Watch Model 1 (DW-9052-2VHDR) at RM199.00 including GST (original price RM379.00); or
 - (b) Casio G-Shock Watch Model 2 (GA-100-1A4DR) at RM299.00 including GST (original price RM569.00).
7. For the avoidance of doubt, the ability of Customers to purchase the Casio-G Shock models defined in Clause 6 above is while stocks of the same last and can only be carried out at the same Shell Station in which the Promotion Pre-requisites were satisfied by the Customer.
8. In order to be eligible for the Promotion Purchase, Customers must present their original Shell-Casio Combo Card complete with the required Promotion Stickers for either Combo 1 or Combo Express at the cashier counter of the Shell Stations for verification and redemption purposes.
9. One original receipts for the purchase of Shell Fuels and Shell Lubricants and original Shell-Casio Combo Card are acceptable for the purposes of this Promotion. No photocopy, damaged and/or the like of receipts and the Shell-Casio Combo Card will be entertained for the purposes of this Promotion.
10. Shell reserves the right at its absolute discretion to vary, delete or add to any these Terms and Conditions without prior notice or to terminate this Promotion at any time without notice or liability.
11. These Terms and Conditions, as may be amended from time to time pursuant to Clause 9 above, shall prevail over any provisions or representations contained in any other promotional material or advertising of this Promotion.
12. All decisions made by Shell in respect of this Promotion or in the event of any dispute is final and binding.
13. In the event where there is any inconsistency(ies), conflict(s), ambiguity(ies) or discrepancy(ies) between English and Bahasa Malaysia versions of these Terms and Conditions, the English version of these Terms and Conditions shall prevail.

14. Shell reserves the right to cancel, terminate or suspend this Promotion with or without prior notice. In the avoidance of doubt, cancellation, termination or suspension by Shell of this Promotion shall not entitle the Customers to any claim or compensation against Shell for any and all and all losses or damage suffered or incurred by the Customers as a direct or indirect result of the act of cancellation, termination or suspension.
15. In no event will Shell and its Affiliates be liable for any loss or damages including without limitations, loss of income, profits or goodwill, direct or indirect, incidental, consequential, exemplary, punitive or special damages of any party including third parties howsoever arising whether in contract, tort, negligence or otherwise, in connection with this Promotion, even if Shell has been advised of the possibility of such damages are expressly excluded – including without limitation to any and all claims, charges, actions, proceedings, losses, liabilities, damages, expenses and demands brought by, among others, the Customers and any other third parties in respect of the quality of the Casio Goods and of which shall be Marco Corporation (M) Sdn. Bhd. (details available in product warrantee card) who shall be responsible for the same.
